### Legal Tip: Set Up Emergency Contacts In Your Phone Now

If you're ever unable to communicate after an accident, having emergency contacts ready could make all the difference.

#### Here's how to set it up:

##### iPhone:

1. Open the Health app.
2. Tap your profile picture > Medical ID > Edit Emergency Contacts
3. Add and save your trusted contacts

##### Android:

1. Open the Settings app (Advanced Settings for older versions) > Safety & Emergency
2. Tap emergency contacts
3. Add and save your trust contacts

Congratulations to Adonis McCrary! We're honored to support him on his academic journey and can't wait to see the impact he'll make in the years ahead.


