E-Bike and Scooter Accidents in North Atlanta: What to Know

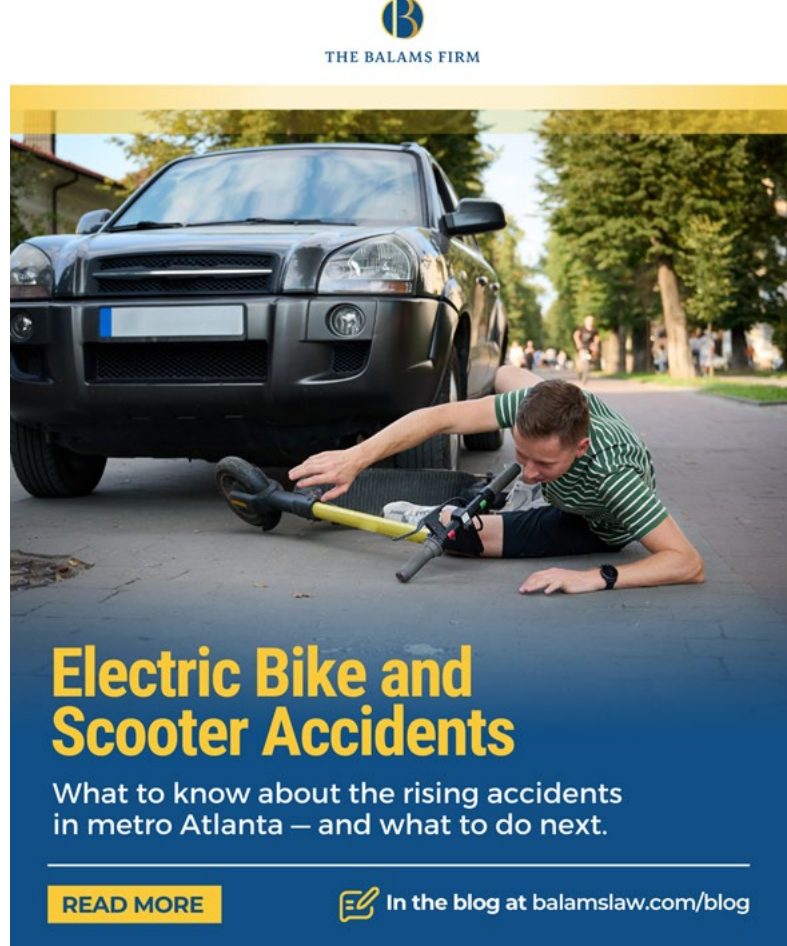
E-scooter injuries surged 80% last year.

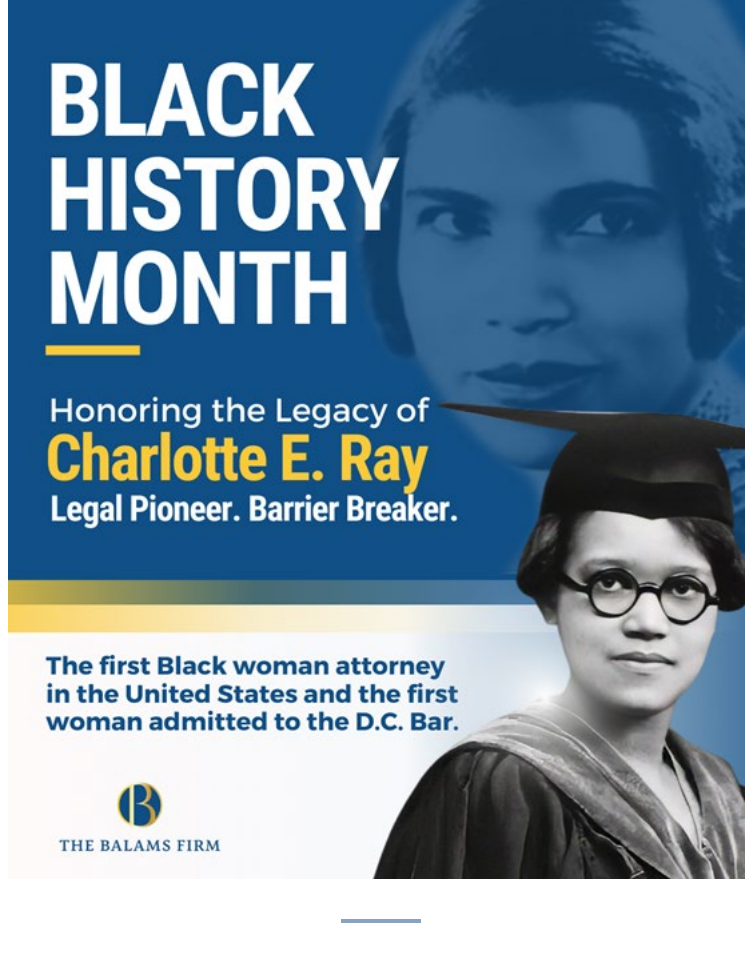

Black History Month: Honoring Charlotte E. Ray

This Black History Month, we honored Charlotte E. Ray, a legal trailblazer whose courage helped reshape the profession.
